REPORTS

Membership (Simon Fellowes)

- ❖ Membership Growth: 33% growth year on year, reaching 405 memberships and over 1,000 total members.
- ❖ Historical High: Largest membership in the club's 40+ year history.
- **Growth across categories**: Stability in tennis, surge in Pickleball and Social members.
- **Key Contributors:** Cassie's team, marketing, FitSportsWA's Friday events, collaboration with Richard and OpenAir, and exposure from "Markets by the Sea"..
- Community Engagement: Increased social events in 2023, with plans to further develop in 2024.
- Hello Clubs: New membership platform to improve data management/ member support.
- Outlook for 2024:
- Focus shift to stability, sustainability, and organic growth over marketing for new members.
- ❖ Introduced flexible, usage-based fees for fairness and transparency.

The committee provided notice to members of the fees set for the financial year 2024 / 2025

- **❖** SPORTS MEMBERSHIP | FAMILY \$375 | SINGLE \$250
- For both tennis & pickleball members, including all benefits of social membership + preferred inclusion in member only sports activities + \$5 discount for each 'pay-to-play' organised sports activities.
- **❖** SOCIAL MEMBERSHIP | FAMILY \$125 | SINGLE \$100
- This membership includes early access to all events held at the club + discounts at the bar
- **❖** JUNIOR MEMBERSHIP | \$80
- For under 18 members looking to take part in tennis or pickleball Inc \$5 discount for each pay-to-play event
- **❖** Pay 2 Play Fees
- Participation fees vary depending on activity but are representative of participants paying for use of facilities

The membership was asked to approve the schedule of fees. The proposal was accepted by unanimous vote.

Operations (Jeff Danylyk / Cassie England)

- Maintenance
- Plumbing Trees have partially crushed the sewer line. A section (from court one to court 4) will need to be excavated/replaced. The playground will be out of service for a period of time and the feature tree beside playground will be removed. We plan to keep a portion of the stump as a climbing apparatus still.
- Gardens and grounds Lawn mowing contract has been expanded to include weeding of gardens. The grounds are always looking neat and tidy now.

- Waste Disposal New rubbish contract is in place. Now using wheelie bins for general rubbish, much easier to manage

- ❖ 78 events at the club from Jan Dec 2023, including: market days, sporting events, club events, private venue hire, deck reservations and workshops.

- Functions / Bar manager ongoing search. Require someone to help support our growing number of functions.
- Marketing engaged Evolution Marketing to support Cassie & Shelley in managing social media channels and managing the website.
- Volunteers we are looking for more volunteers to help out with odd jobs around the club. The committee hope to have a coordinator to help mobilise our greatest asset you the members!
- Thanks to all who step up and lend a hand with bar, organising/ setting up functions, collecting glasses, meeting and greeting new faces etc. A huge shout out to Shane Rayfield who does more behind the scenes duties than most members know. Shane keeps the place moving along! Also thanks to Scotty and Sam for their ongoing support.
- Club Manager Cassie England gave thanks to the wider team of employees, committee members and volunteers who provide invaluable support.

Pickleball (Steve Armson)

Growth of player participation with 50% increase year on year.

- Due to :-
- ❖ Increased court capacity from 6 to 18 as a result of the additional 12 pickleball courts on the lower courts painted in January 2023.
- Adopting the Team Reach app. We now have over 300 players registered on the North Shore Pickleball platform.
- Adopting the Match up and clubhouse TV for doubles player court allocation at social sessions.
- Offering 4 levels of activity on a Tuesday evening (Play & Learn, Beginner Social, Intermediate Social and Advanced Social).
- ❖ Improved court facility on the top courts with the resurfacing and new LED lights.

New pay to play fee structure

- Non-Members social pay to play fee increased from \$7 to \$10 per player from 1st July 2023
- Members social pay to play fee increased from \$0 to \$5.

Running of all organised club pickleball activity has been taken over by FitSportsWA.

Members of NS have obtained National and State pickleball titles and medals.

North Shore has been selected as the venue to host the pickleball event at the **March 2027 World Police & Fire Games in Perth.**

Tennis (Simon Fellowes)

Social Tennis: stronger than ever with tennis on every day of the week

- Sessions for all skill levels: Mondays and Wednesdays (midweek daytime), Wednesday evenings (intermediate), Thursdays (intermediate/advanced), and Sundays (mixed)
- Regular informal matches, especially popular on Saturdays.

Competitive Tennis:

New doubles competition on Mondays + Participation in NDTA: 2 men's teams (Wednesdays) and 2 mixed teams (Saturdays).

Membership Growth: Constant influx of regulars and newcomers.

Coaching: Enhanced offering led by Troy and FitSportsWA since last year.

- Junior programs and 1:1 ranging from beginner to high performance.
- School holiday clinics.
- Adult coaching: beginner to advanced, cardio sessions, and 1:1 lessons.
- Friday kids' night with 50+ kids attending with activities and a sausage sizzle.

Challenges:

- Limited court capacity, especially during evenings.
- Balancing pricing for sustainability and member value.

Finance Report (Simon Fellowes)

2022-23 Update

- Tony O'Brien: stepped down as Treasurer. His contributions will be missed and his assistance in the transition process is appreciated.
- Change from MYOB to Xero to simplify/ support operations
- New Treasurer: Gary Diable is the proposed Treasurer for 2024, with a new Finance sub-committee to assist.
- Financial Highlights to 30 June 2023:
 - ❖ Major turnover growth reflecting the club's transformation.
 - Focus shifting from growth to profitability and sustainability.
 - Profitability improved: From a loss of (\$8,942) to a positive \$23,244 (excluding depreciation).

2022-23 Results Highlights

- CAPEX Expenses for FY23:
- ❖ Total outflow of ~\$85k for club improvements and investment in the future. Included: \$35k (new lights), \$16k (network infrastructure), \$28k (court resurfacing), and \$30k (kitchen upgrades).
- Further large-scale investments are not expected in the near future.
- Committee's Future Focus: Stabilise growth, prioritise profitability, ensure club's long-term sustainability.
- Funding Discussions: Ongoing talks about securing funds for previously discussed developments, aiming for in-house execution to save costs.
